How it Works

How To Use Favipiravir

- Favipiravir tablet should have been taken orally, with or without food, at approximately the same time ever day.
- It should be eaten whole with water. It is not recommended that the tablet be opened, damaged, or chewed.

The standard favipiravir dosage for adults with COVID-19 is 1800 mg orally twice day on day 1, repeated by 800 mg orally twice weekly for 14 days.

Favipiravir Tablet - Side Effects

- Inflammation all over the body, muscular discomfort, asthma, gastrointestinal distress, abortions, seasonal allergies, and allergic dermatitis are all frequent Favipiravir side effects.
- Favipiravir tablet is not recommended for usage during pregnancy since it can harm the fetus.
- Some of the other side effects are increased levels of uric acid in the blood, Diarrhea, White blood cell count is low, Increased levels of liver enzymes.

Some Tips For Favipiravir Use

- Favipiravir is a drug that is used to treat Covid-19 symptoms that are mild to moderate.
- If you have arthritis, uric acid, liver, or renal illness, tell your doctor.
- Favipiravir tablet should be given with caution to senior individuals, who should have their overall health monitored.
- If you notice signs of adverse reactions such as a red or blister rash, trouble swallowing or breathing, or swelling of the eyelid, lips, cheeks, throat, or tongue, seek medical help right away.
- Favipiravir can be taken with or without food. Taking it alongside food, on the other hand, may lessen the risk of vomiting and diarrhea.
- It is recommended that you utilize contraception while using Favipiravir and for the next 7 days after you finish the treatment.
- If you're pregnant or breastfeeding, tell your doctor.

When is the ideal time to begin Favipiravir treatment?

■ Favipiravir is more effective in slightly infected people than in people with severe Covid-19 infection. This is because antiviral drugs like Favipiravir, which are used early in the treatment of Covid-19 infection, have been shown to be more effective. Delaying therapy just slows the process of recovery.

How long should Favipiravir be continued and at what dose?

■ Favipiravir tablet should be consumed according to the doctor's instructions for dosage and duration. The suggested dose is 1,800 mg twice from day 1, maintained by 800 mg twice daily till day 14. It is given orally (by mouth).

Is it safe to use Favipiravir in the children and elderly?

Favipiravir should be provided with caution to the elderly, who often have reduced organ functioning, and should be monitored on a regular basis. Favipiravir has never been given to children.

Who should not take Favipiravir?

■ Patients who are sensitive to Favipiravir tablet and some of its constituents should not be treated with it. Favipiravir should also not be given to children. People with acute kidney or liver illness must not be given it. People who have unusual uric acid levels or suffer from gout should also tell their doctor before using Favipiravir.

Can Favipiravir be taken by women who are breastfeeding or pregnant?

■ Favipiravir should never be used to treat Covid-19 infection in women who are pregnant or nursing. Favipiravir is not recommended for use by pregnant or nursing women since it has the potential to harm the infant.
